EARTH DAY CLEANUP

April 18, 2015

Nine people reported for the morning session, and an impressive 28 bags of trash were collected along Laurel Avenue and around Rockingham. Ten volunteers worked the afternoon session in the Mapleton Preserve and nearby roadsides, which yielded only about 10 bags—for once, there wasn't that much trash! In the Kingston segment of the December 10, 2014 Audubon Christmas Bird Count, a total of 41 species was found, including a new entry for the Kingston segment of the count - a pileated woodpecker observed by Anne Zeman and Mark Peel in the Cook Preserve. For once, snow geese beat out Canada Geese as the most frequent bird in the count, thanks to several big flocks that were migrating through the area. We did not see our local eagles on the count day, but they are nesting in Kingston again this year. Total birds logged by the 4 counters was 1616. PRESERVATION AND STEWARDSHIP FUNDS APPORTIONMENT

Last November, voters approved a constitutional amendment dedicating a small percentage of existing state revenues (without increasing taxes) to establish a long-term, stable source of funding for the replenishment of the now-depleted Green Acres, Blue Acres, farmland and historic preservation programs. The measure also provides for continued funding to improve water quality, remove and clean up underground storage tanks, and clean up polluted sites.

Unfortunately, legislators, the administration, and environmental groups have very different ideas as to how the funds should be allocated. The stakes are high, as the money available is far less—

c. \$71 million per year, as compared with recent amounts as high as \$200 million per year. Of particular concern is a plan in the Christie administration's proposed budget to use \$20 million of the dedicated funds to pay salaries for state park staffers. In the past, that money traditionally came out of the general fund; there is no reason that it should not continue to do so.

At the same time, an Assembly committee measure fails to provide adequate capital spending for state parks. The backlog of capital projects is long and will require substantial expenditure. KGA works closely with D&R Canal State Park staff, and so this is of particular concern to us.

The road to an accord on the implementing legislation will be long and contentious. We will continue to stay involved in discussions and advocacy, and to keep our members informed about developments as they unfold.

PSE&G SUBSTATION

The D&R Canal Commission approved PSE&G's application for a new sub-station on Princeton University property accessed from Route 1 at the Independence Drive jug-handle.
